Second Stated Meeting of the Lowcountry Presbytery April 26, 2016

The Second Stated Meeting of the Lowcountry Presbytery was held at 9:00 a.m., April 26, 2016 at Trinity PCA, in Orangeburg, SC.

Worship Service	TE John Mark Patrick, associate pastor of Trinity PCA in Orangeburg, SC led the Presbytery in a Psalm of Praise: Psalm 95:1-6. He then read Psalm 100 as the Call to Worship and opened in prayer. The presbyters then stood and sang, <i>I Greet Thee</i> <i>Who My Sure Redeemer Art.</i> TE Sean Sawyers led in prayer and then read a passage from Philemon after which an offering was taken. Presbyters stood and sang, <i>Poor</i> <i>Sinners, Dejected with Fear</i> and then responsively joined in a Corporate Confession of Sin. TE Sawyers proclaimed Psalm 32:1 as an Assurance of Pardon and the worshipers responded by singing the Doxology. TE Sean Sawyers preached a sermon from Hosea 2:8-17 entitled <i>God's Tenacious Love</i> . The presbyters then stood and sang <i>How Sweet the Name of Jesus</i> Sounds after which TE Sawyers properly fenced the table and led the presbyters in celebrating the Lord's Supper.
Ministry Equipping	Dr. Doug Kelly, shared with presbyters on the vision and plan to provide for theological training for African American and other pastors in the Charleston area. Hopefully this ministry will begin in Fall of 2016.

- The Freshmen Girls Small Group has grown throughout the year and has 12 regular attenders.
- 4 freshmen have begun reading the Bible on their own for the first time and 2 girls are going through Knowing God (Packer) with our female intern Annie Kate Barr.
- 2 sophomore girls have begun reading Instruments in the Redeemer's Hands and meeting with Annie Kate to discuss it.
- Our guys and girls sophomore small groups have nearly completed at 12 week study on the covenants and the student response (as light bulbs go on in their heads) has been remarkable.
- We added 5 new students to our leadership team this spring and will have 3 more joining us in the fall.
- We have been assigned an extremely gifted male intern named Philip Rohrer who will be arriving sometime this summer! We've truly been blessed with a "Dream Team" of interns for this upcoming year.

Areas for Prayer:

• Annie Kate Barr and The Clark Family each need \$5,000-\$10,000 of increased financial support to keep RUF going on CofC's campus this year.

• We are graduating a class of 16 seniors and they will be leaving a void of leadership and energy. Although they are probably our largest graduating class RUF@CofC has ever had, they are also the youngest in their faith. They need more than any other class, the blessing of finding good churches in their new communities as they disperse literally across the world.
