• Budget 2017: A great big thank you to all of our churches in the Lowcountry Presbytery for your financial commitments for 2017! We were facing a budget shortfall if we fully supported our campus ministries and church planting efforts with our previous levels of giving, so the Administrative Committee offered two budgets at our last presbytery meeting – Balanced & Needed, with the balanced budget cutting significant ministry areas. At our Fourth Stated Meeting it was moved & passed "to adopt the needed budget provided that between now and the end of year that the Treasurer provide a report to provide to the churches to come up with as much as possible and then indicate that commitment by the 1st of the year. Based upon those commitments the administrative committee come forward at the Jan 28th Presbytery with a proposed budget depending upon support expressed from the churches." Our Treasurer has received commitments from all of our churches for \$50,000 for 2017 which means we can meet the "Needed" budget and we do not have to make ministry cuts for 2017. In light of this the Administrative Committee recommends that we continue to operate with the previously submitted "Needed Budget for 2017" as our budget for 2017.
