Call to Order

The moderator asked the Recording Clerk if there was a quorum. The Recording Clerk declared that a quorum was present per BCO 13-4.

Business & Reports:

The business of this Specially Called Meeting of the Lowcountry Presbytery is to address a matter concerning TE Danny Clark and his work as RUF Campus Minister at the College of Charleston.

TE Rob Hamby opened in prayer.

M/S/C: That to receive and affirm TE Clarks request to dissolve his call as Campus Minister with RUF to the College of Charleston.

Motion from Campus Ministries Committee:

M/C: The Campus Committee requests that they be commissioned by the Lowcountry Presbytery to work with the national RUF office to find a new RUF minister for the College of Charleston.

M/S/C: Motion to move into executive session to deal with the matters concerning TE Danny Clark and RUF at the College of Charleston..

TE Danny Clark and RE David Walters were asked to leave the room.

EXECUTIVE SESSION FOLLOWED

Public Statement Approved from the Executive Session:

M/S/C: Conclusion, judgment and decision:

On Tuesday February 16, in accordance with BCO 38-1 regarding a case without process, TE Danny Clark made a full statement and confession of his sin before the court. Lowcountry Presbytery approved TE Danny Clark's confession of his sins of breaching boundaries in ministry and using poor judgment and discernment in ministry. There is no evidence that TE Danny Clark engaged in any scandalous or sexual sin. In keeping with BCO 36-2 regarding the need for church censures to be suited to the nature of the offenses, Lowcountry Presbytery administered the censure of indefinite suspension (BCO 36-5) to TE Danny Clark until he is able to give satisfactory evidence of his repentance. Lowcountry Presbytery entrusted TE Danny Clark into the care of the Shepherding Committee.

TE Hamby indicated that RUF has suggested TE Clark be provided with 14 weeks of severance package. This requires continued support by the presbytery as TE Clark received the ministry with a \$17K deficit.

TE Hamby asked that we pray for the ministry of RUF at the College of Charleston. There was season of prayer for the ministry at College of Charleston.

TE Hamby reported that the Campus Ministries Committee is already working with RUF on a replacement so that we might have a minister on the field by Fall.

RE Walters as treasurer asked the question if the presbytery would continue to support the College of Charleston.

M/S/C: That the Lowcountry Presbytery continue to support the College of Charleston RUF ministry as our current budget already passed allows that.
